M Meet Mats Holm, Director of Information Technology, and Daniel Knoblauch, Systems Administrator, the November 2024 recipients of the Staff of the Month Award.

On August 22, 2024, the LISD suffered a catastrophic event that significantly impacted the district's information technology (IT) systems and those of Addison Community Schools and Britton Deerfield Schools. Upon learning of the incident, Mats and Daniel took immediate action to shut down various systems in an effort to isolate the damage, while also communicating with the district administrative teams. Mats and Daniel took proactive steps to mitigate the damage, while also attempting to minimize the operational impact to the affected districts.

Over the course of the following month, Mats and Daniel accumulated well over 120 hours of additional work time each, regularly working 12-18-hour days, seven days a week. They served as an onsite resource to the external experts that assisted the LISD in rebuilding the necessary IT systems, substantially reducing the costs that would have been required to obtain onsite support. When confronted with a series of challenges, Mats and Daniel continued to work towards a positive resolution that maximized the district's return while limiting its costs and operational impact. Their commitment to the LISD, Addison, Britton Deerfield, and the staff and students of each district during this stretch was exemplary and reflected a level of above-and-beyond that would be hard to match. With the ever-growing role of IT in instruction and learning, the LISD is incredibly fortunate to have Mats and Daniel as part of its IT team.

Congratulations, Mats and Daniel, for the outstanding contributions you have made recently and over the years to the LISD, which led to your selection for this award.

Recognition**1. LISD Middle School Student Recognized by Local School District for Positive Behavior****(Alena York)**

Summary: A Lenawee Intermediate School District student from the moderate cognitively impaired middle school classroom was nominated and chosen to receive a positive behavior intervention and support award.

Tecumseh Middle School recognizes students for exhibiting excellence in one or more of their school-wide expectations. Their school-wide expectations include Ownership, Never Give Up, and Empathy. Students must also maintain good grades and attendance. Tecumseh Middle School only selects a small number of students to receive this award. The selected students are honored on the Tecumseh Middle School Hall of Fame. Elijah Myers was selected for this award for the month of October.

In addition to this award, Elijah had the opportunity to present at the Region IV Assistive Technology conference in Macomb County. Elijah demonstrated his communication skills using his device, Language Acquisition through Motor Planning – Words For Life (LAMP-WFL), by introducing himself and answering a few basic questions. Additionally, videos were presented of Elijah using LAMP-WFL and visuals in the community. Information was also shared about his successful communication with the medical community, allowing him to share his opinions and responses.

1. Project SEARCH to Host Parent Training Series**(Alena York)**

When students with disabilities graduate high school or complete their public-school education, their supports transition to state and community agencies. Navigating these numerous agencies can be confusing and overwhelming for students and parents. LISD classroom staff at Project SEARCH interact with these agencies on a regular basis to ensure their interns not only are employed but also have the resources needed for independent living, further training, and recreation.

Project SEARCH instructor Glen Bowman recognized this continued need for supporting families to better navigate this process. During the 2024-2025 school year, he is hosting a parent training series focused on supporting students and families access agency supports. Glen has invited all students and families currently enrolled in an LISD post-secondary or secondary program, as well as local district high school students with individualized education plans (IEP), to attend this series.

In addition to Glen providing guidance and recommendations on how to access these services, he also invited an agency representative to attend and provide information to families. Several agencies have confirmed attendance and selected a date to attend. Agencies currently scheduled to attend include Michigan Rehabilitation Services, Lenawee County Mental Health Authority, disAbility Connections, Goodwill Industries, Michigan Works, and Social Security. The first meeting date is scheduled on November 18, 2024, and will be held at the LISD TECH Center.

2. Special Education Teacher Assistants Participate in Professional Learning through Master Teacher

The LISD employs 58 special education teacher assistants supporting students in preschool through post-secondary classrooms. A frequent request from this group is relevant training to help them better support students. The special education administrative team has provided a variety of training activities over the course of the last several years. Due to the variety of students served and the different locations of the sites, meeting the training needs of all assistants has been challenging. The special education administrative team researched possible solutions and discovered Master Teacher.

Master Teacher offers a variety of products and services to support those working in education. After reviewing their professional learning opportunities, particularly for teacher assistants, and consulting with both users of the product and the Master Teacher team, the special education administrative team decided to promote their teacher assistant professional learning platform to the LISD special education teacher assistants.

Master Teacher provides 150 online professional learning opportunities with topics ranging from general special education overview to topic-specific training, such as feeding, autism spectrum disorder, and behavior supports. All courses are self-paced, include a post-training assessment, and are aligned with the Council for Exceptional Children standards for paraeducators. The LISD currently has 34 teacher assistants who will be participating in this opportunity. Feedback will be provided and reviewed to determine if continued support of Master Teacher for professional learning will be endorsed.

1. 2024-2025 STEM Event Calendar

(Jackie Murray)

The Lenawee Intermediate School District is proud to announce dates for the 2024-2025 STEM event calendar. These events will be hosted by the LISD Science Curriculum Consultant and STEM Coordinator.

The Challenge, formerly known as “You Be the Chemist,” is developed by the Chemical Education Foundation. This competition is designed for students in grades 5-8, who work cooperatively in groups of three to four. The Lenawee Chemical Collaborative has partnered with the Lenawee Intermediate School District for the third year in a row. The competition will be held on February 24, 2025, at Adrian High School’s Performing Arts Center.

The Tri-County Science Olympiad will be held at Siena Heights University on March 4, 2025. This opportunity is designed for students in grades 3-5.

The Tri-County STEM Fair will be held at Adrian College on March 17 and 18, 2025. Students can create projects to demonstrate their learning across a variety of fields. Students in grades 5-12 are encouraged to participate.

2. Moving Science and Literacy Outdoors

(Jackie Murray, Emily Stiver, Amanda Morris, Kerry Nieman)

Ten Lenawee County teachers participated in full-day professional learning on June 10, 2024, with the LISD Science Consultant, Literacy Consultant, Early Literacy Coach, and Environmental and Outdoor Education Coordinator. The aim of this was to learn the benefits of engaging students in learning outdoors in addition to integrating science and literacy standards together. These teachers then participated in a follow-up Zoom on September 5, 2024, to discuss the accompanying summer book study, *Literacy Moves Outdoors*. This also provided the opportunity to sign up for a time for the Science Consultant and Early Literacy Coach to model the lesson in their classrooms.

3. JC/LISD Academy Students Begin Utilizing iWellness Platform

JC/LISD Academy students have begun weekly check-ins using the iWellness platform. This platform allows staff to monitor student wellness and provide targeted assistance to those in need of additional support. Through this weekly check-in process, insights into the wellness needs of students can be gathered more effectively.

4. JC/LISD Academy Students Participate in Community Service and Experiential Learning Activities

(Kim Dusseau)

On October 26, 2024, JC/LISD Academy students participated in a “chalk the walk” activity, creating drawings and writing inspirational messages for the residents of Gaslight Village Assisted Living. Early Middle College students are required to do 100 hours of community service, a 40-hour internship, or a combination of both to earn their Michigan Early Middle College Association (MEMCA) certificate. In addition, Academy students who complete more than 100 hours of community service will earn a green honor cord for graduation.

On October 3, students from the JC/LISD Academy visited the Fallen Timbers Battlefield to explore sites that commemorate the 1794 Battle of Fallen Timbers and the War of 1812. Students learned about the history, nature, and culture of the region at the battlefield, monument, and fort.

5. JC/LISD Academy Students Take Standardized Assessments

To measure student growth, JC/LISD Academy English, Algebra I, and Algebra II students took the NWEA math and reading assessments on September 24-26, 2024. The Academy has set a school-wide student growth goal, aiming for 80% of students to achieve high growth or high achievement on the spring assessment.

On October 9, juniors at the JC/LISD Academy took the PSAT/NMSQT assessment, which is being offered digitally again this fall. The digital version is substantially shorter than its paper-and-pencil predecessor, lasting just two hours and 14 minutes instead of nearly three hours. Students also have more time, on average, to answer each question, which means the digital PSAT/NMSQT focuses more on measuring skills and knowledge rather than test-taking speed. Additionally, the assessment features shorter reading passages and includes a built-in-calculator that can be used throughout the Math section. First and second-year Academy students toured Hillsdale College while juniors were taking the PSAT/NMSQT.

6. Adult Learning Services @ LISD TECH Center Enrollment Report 2024

(Amy Hinkley and Angie Williams)

Summary: Adult Learning Services (ALS) @ LISD TECH Center continues to serve Lenawee County residents and employers.

Adult Learning Services @ LISD TECH Center has traditionally conducted its enrollment count in September to provide an early forecast and comparison with previous years. Typically, this count primarily includes fall enrichment courses and a few vocational courses that begin in September. It reflects enrollments and course offerings from July 1, 2024, through October 1, 2024.

Here are a few highlights:

- 1) ALS @ LISD TECH Center has partnered with Lenawee NOW to establish an automotive dealership collaborative, bringing together auto dealerships in the county to discuss their hiring and retention challenges. Through these discussions, it was discovered that they all had a group of individuals who have never progressed beyond working in the oil and lube services area. While they gained skills in brakes, steering, suspension, and other areas, they were unable to advance due to not passing the state licensure tests. In response, ALS @ LISD TECH Center is now hosting classes in brakes, steering, suspension, and electrical systems. To date, trainees have earned a total of 52 state licenses with only one participant not passing. These training sessions will be offered again in the coming year.
- 2) The successful partnership with Condensed Curriculum International (CCI) continues to provide a range of training opportunities in the medical field for area residents. If there are not enough students enrolled to justify an in-person course, participants still have the option to take the course online.
- 3) In addition, ALS @ LISD TECH Center continues to promote other enrichment course offerings provided by Lenawee County non-profit agencies, which will be included in the course catalog scheduled for mailing in mid-December.

Career Preparation Services Coordinators have facilitated presentations of LISD TECH Center opportunities to sophomores throughout Lenawee County. Students watch a video about LISD TECH Center programs and receive a brochure. Students had the opportunity to visit the Center for a Sustainable Future on October 16-18. They will also explore main campus programs December 2-6, 2024. Finally, an open house is scheduled for December 12, 2024, from 5:30-7:30 p.m. The LISD TECH Center application period will begin January 3, 2025.

1. 2023-2024 Fiscal Year Audit & Single Audit Completed

Summary: The District's audit report for fiscal year 2023-2024 has been issued by the audit firm Maner Costerisan PC.

Lenawee Intermediate School District's audit report for fiscal year 2023-2024, issued by Maner Costerisan PC, Certified Public Accountants, is provided under separate enclosure. The District received an unqualified opinion, meeting the highest level of excellence in audit standards for financial statement reporting.

It is requested that the LISD Board of Education accept the 2023-2024 fiscal year audit conducted by Maner Costerisan PC. The District's audit must be submitted to the State of Michigan by November 1, 2024.

It is recommended that the LISD Board of Education a) accept the District's 2023-2024 fiscal year audit as prepared and submitted by the Maner Costerisan PC audit firm, and b) designate 2023-2024 fiscal year Medicaid funds in the amount of \$820,837.

Facilities Updates

1. 2025-2026 Capital Improvement Projects

(Tom Kasefang)

LISD buildings and associated grounds are inspected annually to evaluate current conditions and identify any need for updates. Information gathered during these inspections and findings from the 2017 Facilities Assessment are compiled in the LISD Twelve-Year Capital Improvement Plan, allowing staff to effectively plan for various projects.

For the 2025-2026 school year, LISD staff are considering the following capital improvement projects:

SPECIAL EDUCATION

Milton C. Porter Education Center

- Interior door replacement - Many of the classroom doors have significant wear and are beginning to delaminate.
- Gymnasium bleacher replacement – The existing bleacher’s mechanical components are worn and in need of replacement. The bleachers also lack handrails at the ends and down the center, which is required by code.

Trenton Hills Learning Center (THLC)

- Paving parking lots and drives - Multiple areas of asphalt at the Trenton Hills Learning Center are under consideration for replacement. Significant cracking and spalling are evident in the front and rear parking areas as well as on the main drive. Additional drainage will be added if necessary.
- Playground shelter – LISD staff are considering the addition of a shelter at the north playground of the Trenton Hills Learning Center. The purpose of the shelter is to provide shade for students during the summer months. The simple structure would consist of a concrete floor and a covered roof.

Laura Haviland

- Improvements to Room 670 - Enhancements to Room 670, which serves as the student time-out area, are currently under consideration. This room is not conducive to managing upset or agitated students. The objective would be to create a safe, durable, calming space for students to recover.

Transportation Services

- Fuel pump canopy – A canopy to protect the fuel dispensing pumps at the Transportation Services building is under consideration. The canopy would shield the pumps and associated electronics from inclement weather.

CAREER AND TECHNICAL EDUCATION

LISD TECH Center / TECH Center North

- Painting entrance canopies – The canopies at the LISD TECH Center's main entrance, the TECH Center East building, and the TECH Center North building need repainting.

The protective coating on the steel support beams and the underside of the roofing deck is cracked, peeling, and in poor condition. This work was included in the 2023-2024 LISD TECH Center Secure Vestibule project, which was canceled due to higher-than-expected costs.

- Welding lab HVAC improvements – Since the construction of the LISD TECH Center Welding addition in 2016, the welding program has added additional equipment. While this equipment enhances learning opportunities for students, it has significantly increased the load on the building's HVAC system, resulting in periodic overheating. While much of the welding equipment is equipped with filtration capabilities, the lab's overall filtration is poor.

LISD staff would like to address both issues with modifications to the existing HVAC system.

- Old horticulture building – Improvements to the old horticulture building are currently being considered. The building, which the LISD recently re-acquired with the purchase of the Jackson Community College (JCC) property, previously served the LISD TECH Center Horticulture program. In February 2021, Dailey Engineering completed an assessment of the building indicating that the building's masonry and steel roofing structures were in good condition overall.

Needed improvements include a new roof, HVAC system, window, exterior doors, and flooring.

- LISD TECH Center restroom – Improvements to the women's restroom in the LISD TECH Center's west wing are under consideration. While the restroom is still functional, it's overall condition is worn and outdated. LISD staff plan to maintain the

current fixture layout with updates to the tile, countertops, and partitions.

- Flooring improvements – Replace worn and stained carpeting in the LISD TECH Center’s Student Services area, Accounting classroom, and Graphic Design classroom.

LISD staff are requesting Board approval to develop bid specifications and seek bids for the 2025-2026 Capital Improvement Projects.

It is recommended that the LISD Board of Education approve the request to develop specifications and seek bids for the 2025-2026 Capital Improvement Projects.

Special Education

LISD Preschool Staff Begins Training for Early Childhood Positive Behavioral Interventions and Supports

On August 29, LISD preschool classrooms began implementing Positive Behavioral Interventions and Supports (PBIS) using the Pyramid Model for Promoting Social and Emotional Competence in Infants and Young Children, focusing on social, emotional, and behavioral health for young children. Staff will participate in five half-day training sessions before the rollout. An Early Childhood (EC) PBIS leadership team, comprising 10 diverse members, will guide the implementation, meeting monthly. Their role is to ensure effective practices are adopted and systems are in place to support staff and data usage. Research shows that program-wide implementation improves child behavior, social skills, staff satisfaction, and teacher confidence.

Instruction and General Services

LISD TECH Center 2024-2025 Preliminary Student Enrollment

The LISD TECH Center reports preliminary student enrollment of 1,079 students (547 AM and 532 PM students) for the 2024-2025 school year as of September 15, 2024. This reflects an increase of 51 students compared to the previous year.

LISD TECH Center to Recognize Business Partner of the Year

For the seventh year, LISD TECH Center will recognize a Business Partner of the Year, with Big C Lumber selected as the 2024 recipient. Big C Lumber is a strategic partner for the LISD TECH Center's Residential Construction program and a partner of the Gold Hammer Award.

2024 LISD Summer Lit Lab Pop-ups

This summer, the Lenawee Intermediate School District (LISD) launched the Lit Lab Pop-ups program, partnering with five schools and four community sites to boost literacy skills for 1,473 kindergarten through fifth-grade students. Over six weeks, 53 volunteers and teachers implemented engaging activities, including read-alouds, STEM projects, and writing workshops, with a focus on improving writing skills. Each student received a book to encourage reading at home, along with weekly resources for parents. Feedback was overwhelmingly positive, emphasizing the program's effectiveness in preventing summer learning regression and its value for students in Lenawee.

LISD and Hudson Area Schools Team Up on 23h Grant

The LISD and Hudson Area Schools partnered on the 23h Math Grant to address math needs identified by the Michigan Department of Education. The partnership focuses on Essential Instructional Practices in Early Mathematics (K-5), emphasizing interactive number sense routines. A key aspect of the grant is hiring an Early Math Specialist, who is coaching eight selected PK-5 Hudson Lincoln teachers using the Number Corner tool. The project, currently funded for one year, hopes to secure future funding.

LISD TECH Center Recommends Purchase of Advanced Driver Assistance System Equipment

At the September 2024 LISD Board meeting, staff received permission to seek bids to purchase Advanced Driver Assistance System (ADAS) equipment for the LISD TECH Center Automotive Services Technology program, funded by the Margaret Dunning Foundation grant. The equipment is essential for training the next generation of automotive technicians on the fundamentals of ADAS as it is the fastest-growing segment in the automotive service and repair industry. Three bids were received from two companies. The lower bid from Auto-Wares Tool Company meets all requirements.

2024-2025 First Revision Budget

LISD's first revision budget process for fiscal year 2024-2025 is currently underway. Local property taxes are the District's major revenue source. Taxable values within LISD's tax boundaries include properties in Lenawee, Monroe, Hillsdale, Jackson, and

Washtenaw Counties. LISD’s taxable values for 2024-2025 (as of May) reflect a 6.63% increase from the prior year. The inflation rate multiplier for the Headlee calculation decreased from 7.9% (1.079) to 5.1% (1.051). The 2024-2025 budget was built on the recommendation from the county of a 5.0% increase in taxable value. The 2024-2025 first revision budget information is scheduled for consideration and adoption by the LISD Board of Education during the December 2, 2024, meeting.

Cooperative Services

Lenawee/Monroe Technology Consortium Works to Obtain Universal Service Funding (USF)

Authorization is requested to develop specifications and seek bids for technology and related service needs that may or may not be eligible for Federal Universal Service Fund (USF) reimbursement beginning July 1, 2025, through June 30, 2026.

Office of the Superintendent Reports

District-wide Phone System Upgrade Recommended

The LISD's phone system, installed in June 2018, has been reliable; however, the software license and support contract are up for renewal, and the hardware is nearing end-of-life. The system consists of 254 phones integrated with public address systems and two

redundant servers. In May 2024, the Board authorized seeking bids for an upgrade. Two bids were received. The IT team recommends accepting InaComp's bid of \$45,785, noting price differences due to Cisco's discounting practices. The new system will include two virtual servers, software, five years of support, and installation. The total cost will be \$45,785 for five years, funded across major LISD budgets and included in the FY 2024-2025 budget.

Purchase Proposal for the Telamon Corporation Modular Building

In August 2024, Telamon Corporation proposed selling the modular building located on LISD property at 1372 N. Main Street, Adrian, for \$50,000, "as is." This 7,000-square-foot building, used by the LISD PREP Academy since 1998, is appraised at \$117,888. The initial lease, established in 1998, allowed for shared educational use, and the current lease is valid until June 30, 2025. LISD occupies the building during the school year, while Telamon uses it in summer for a summer migrant youth program; however, it has not been utilized for that purpose in recent years. Upon lease termination, LISD has the first right of refusal to purchase the modular building. If LISD declines or no price agreement is reached, Telamon must remove the building 30 days prior to termination at its own expense. LISD administration requested that the Board of Education consider the proposal and direct them to explore options for purchasing or removing the modular building in alignment with the district's long-term facilities plan. In response, LISD Board President Hartley said the district has a valid use for the building and suggested offering Telamon a fair and reasonable price. LISD Board Trustee Kathryn Mohr questioned the appraisal process, particularly how the building could be moved intact, and suggested obtaining an independent estimate for demolition costs.
